Other committee Updates:

Cage Grant - We haven't received any applications as of yet. We will list something on Facebook to remind people.

Chimney Swift Tower - We have 2 applications as of now with all needed info. The school that we awarded with contingencies last year are losing their chimney and need to re-build.

Nominating - 5 BoD members are expiring in 2017. We have 2 of those running again this year and will have 3 open spots. 1 candidate thus far - from the Indian Trail area, seems really good. Put something on Facebook to encourage candidates. Having another vet would be good, especially if Dr. Joni is rolling off. Send any candidate ideas to Toni.

• Need to approve a second version of minutes that has been screened/cleaned up, to be made available on website for members?

The minutes are more detailed than needed. Create more of a summary going forward and for going on the website. Savannah will go through previous minutes for 2016 and update.

• Welcome package for new board members – present 1st version, discuss

All got a short list of what is proposed to give to new board members. Does anyone have anything to add or edit for this list? A welcome letter with all the links to everything along with the latest newsletter. We should also connect new board members with board buddies. Who will be responsible for this? Mathias, Cathy, and the Nominating Committee will connect to work out details.

Tracking board/volunteer time

Savannah will send information on volunteer tracking. The online forms are very user friendly.

Budget – present 1st draft

Transparency on where funds go and come from is important. We should look at a budget at each meeting. Being a non-profit needs fiscal transparency. It's a work in progress.

"Quicken" challenge

Records are kept on Quicken and the files are passed from treasurer to treasurer when the roles change. There was trouble with transferring files this time. A proposed solution is for WRNC to load Quicken on the laptop that we currently have and move the laptop from treasurer to treasurer. We will need to purchase a new version of Quicken because the version has no more 'loads'. Jean will remain the treasurer until all is resolved. Suggestion of using Quick Books online. We need historical data and we may not be able to retrieve or mesh the 2 different software.

- VSL's:
 - job description and summary document 2 doc's to review

Rebekah is working to recruit around NC State. We have 4 VSL's at all times, 2 currently doing things with us and 2 new ones (waiting to take over and learning). We should list all 4 on the contact list, role call for meetings, and website. Symposium committee is working on doing something to acknowledge the outgoing VSL's at the banquet at the symposium.

- Symposium 2017 planning:
 - o hotel, banquet, banquet speaker, etc.

Registration starts Mid-November. BoDs need to register. We don't have the information about hotel yet. Dr. Degrenes is going to be the speaker at the banquet. Will put information on Facebook when ready and have all the details. Ice-breaker Lou Mitchell and Betty Holloway are taking this on this year. We need to be more clear to have folks go through the website to register so they also become members. We have a good number of speakers. Always need more items for the raffle.

Display at NC Convention Center

Right now all are NCWRC displays. Kelley is working on this project. Using some items from the museum (taxidermy animals). This is an opportunity to showcase some of the facilities within the state. Please send items to Kelley. Mathias will share photos of what the display currently looks like to give an idea of what Kelley is working with.

Call for other New Business:

There was an interest in doing the t-shirt design in sweatshirts. If we order within the next couple of weeks we can have done for the symposium. Should also consider doing larger sizes with the sweatshirts. Prices are as followed: 48 pieces - \$15.62/shirt for a total of \$805. 72 pieces - \$13/shirt for a total of \$936. If we sell the shirts at \$20 a piece we will make a profit of \$4.28 per shirt. Mathias motions to go forward with purchasing sweatshirts and doing 72. Elizabeth seconds. Vote is unanimous to purchase 72 sweatshirts. Linda will share the color chart with everyone to choose the color.
